

## **Exam Terms and Conditions**

Please read and accept the terms and conditions below. If you do not accept these terms and conditions, your session will end and cannot be restarted, and you will forfeit the exam fee.

### **Confidentiality**

Relativity makes exams available to you solely to test your knowledge of the exam subject matter for which you seek certification. It is made available to you, the examinee, solely for the purpose of becoming certified in the area referenced in the title of this exam. You are prohibited from disclosing, publishing, reproducing, or transmitting this exam, in whole or part, in any form or by any means, whether verbal or written, electronic or mechanical, for any purpose.

This exam is confidential. Confidential information includes the subject matter and contents of the exam, which may not be disclosed as set forth above, including to any Relativity employee not affiliated with the Relativity Certification Program. A disclosure of confidential information by any means in violation of these terms and conditions undermines the integrity and security of the program and will be grounds for Relativity to invalidate any of your exam results and/or certifications, and deny applications to sit future exams.

### **Exam Security and Integrity**

Relativity reserves the right to invalidate any of your exam results and/or certifications, and deny applications to sit future exams if Relativity believes you violated these terms and conditions and/or engaged in any misconduct. Additionally, proctors are authorized to take immediate and appropriate measures against examinees who violate exam rules.

This policy is enforced to maintain the integrity and value of the exams and Relativity Certification Program and ensure that only qualified individuals are certified.

Examples of misconduct and/or misuse of the exam include, but are not limited to:

- Modifying the original results report for this exam or any other exam records
